Action Plan Steps and Expenditures

- 1. Complete the <u>BOY Acadience Data Analysis and Instructional Planning Protocol</u> within one week of receiving the Acadience BOY data. (All components of the Data Analysis and Instructional Planning must be completed.)
- 2. Complete the <u>MOY Acadience Data Analysis and Instructional Planning Protocol</u> within one week of receiving the Acadience MOY data. (All components of the Data

- Analysis and Instructional Planning must be completed.)
- 3. Progress Monitor using Acadience Progress Monitoring Guidelines. Each student will be progress monitored following the suggested progress monitoring guidelines established by Acadience Learning.
- 4. Meaningful, Ambitious and Attainable <u>Acadience Goal</u> set for all students within two weeks of receiving the Acadience BOY data.
- 5. Guarantee Tier 1 instruction is delivered every day using the core Tier 1 curriculum. Heggerty, ECRI and Wonders.
- 6. Administration observes students spending time in text in various portions of the literacy block each day.
- 7. Establish and implement a Tier 1 observation plan to ensure each 1st- and 2nd-grade teacher is observed and given feedback in literacy instruction by an administrator once a month between BOY and EOY Acadience Benchmark.
- 8. Set up and complete four or more observation and feedback sessions with the Early Literacy Teacher specialists for <u>Heggerty</u>, <u>ECRI</u>, and <u>Wonders</u>.
- 9. Refer to the school plan goal at the start of every CTM/Data Meeting. Incorporate instructional best practices during CTMs (e.g. use of Scarborough Reading Rope).
- 10. Acadience progress monitoring data is reviewed monthly to track growth towards benchmark goals and adjust Tier 1 when needed.
- 11. Ensure that all 1st- and 2nd-grade teachers have been trained on how to use Heggerty, ECRI and Wonders as part of Tier 1 instruction. This training can take place at a school level by the Instructional Coach.
- 12. Hire a teacher or increase the number of hours for identified ESPs to teach literacy skills to students.
- 13. Purchase supplies for students and resources for teachers for literacy needs.
- 14. Purchase bookcases for storage of literacy materials to be used for targeted planning and/or literacy instruction with students.
- 15. Purchase technology resources to enhance literacy instruction with students at the school.
- 16. Purchase curriculum materials, library texts, decodable resources, guided reading materials, or leveled library books to be used to increase students' time in text.
